THE REGULAR MEETING OF THE DARBY TOWNSHIP BOARD OF COMMISSIONERS WAS HELD ON OCTOBER 20, 2021, AT 7:00PM AT 21 BARTRAM AVENUE (DARBY TOWNSHIP), PENNSYLVANIA, 19036.

COMMISSIONER GOUGLER, PRESIDENT CALLED THE MEETING TO ORDER AND ASKED FOR A MOMENT OF SILENCE AND THE PLEDGE OF ALLEGIANCE TO THE FLAG.

COMMISSIONER GOUGLER OPENED THE MEETING AT 7:00 PM ON WEDNESDAY, OCTOBER 20, 2021.

COMMISSIONER LACEY, VICE PRESIDENT-THE BOARD MET IN EXECUTIVE SESSION TONIGHT TO DISCUSS PERSONNEL MATTERS.

COMMISSIONER GOUGLER OPENED THE FLOOR UP FOR PUBLIC COMMENT AND ALLOWED THREE MINUTES PER RESIDENT.

RITA VIDETTO-1089, GLEN CIRCLE-UM, SOME OF YOU MIGHT ALREADY KNOW WHY I'M HERE TONIGHT. I'M LIVING NEXT TO SOMEONE WHOSE LIVING IN DEPLORABLE CONDITIONS. THE POLICE TOOK HER OUT OF THE HOUSE ON SATURDAY NIGHT WHERE THEY FOUND FECES, DEAD MICE, LIVE MICE. THE SMELL IS SO BAD IT'S COMING INTO MY HOUSE. IT COST ME A COUPLE OF HUNDRED DOLLARS YESTERDAY FOR THE EXTERMINATORS TO COME TO MY HOUSE. I WANT TO KNOW HOW DEPLORABLE A PLACE HAS TO GET BEFORE SOMEBODY WILL DO SOMETHING ABOUT IT. NOW, HER SON SAID HE'S GONNA COME AND HELP HER CLEAN BUT IT WILL TAKE HIM FIVE WEEKENDS TO CLEAN THIS UP. IF HER SON WAS GOING TO COME CLEAN IT, HE WOULDN'T HAVE MADE IT GET LIKE THAT IN THE FIRST PLACE BECAUSE THIS HAS BEEN GOING ON FOR A WHILE. BUT I WANT TO KNOW WHAT ELSE DO I HAVE TO DO? I'VE CALLED ALMOST EVERYBODY. I PESTERED EVERYBODY I KNEW YESTERDAY TO TRY TO GET ME SOME HELP FOR THIS WOMAN. YOU HEAR ABOUT THIS STUFF ALL THE TIME. ELDERLY PEOPLE LIVING LIKE THIS. HER TOILET DON'T WORK. THEY SAID THEY CAN'T DO NOTHING TO THE HOUSE BECAUSE OF THE STRUCTURE. THE TOILET DON'T WORK. THE SINK DON'T WORK. SHE WOULDN'T BE PEEING AND POOPING ON THE FLOOR AND LEAVING IT IN PAPER TOWELS. I GAVE EVERYONE PICTURES OF THIS. THE NEW HEALTH INSPECTOR, HE WAS VERY NICE, CAME OUT THE OTHER DAY. BUT WHEN IS ENOUGH ENOUGH? THERY'RE GONNA RELEASE HER FROM THE HOSPITAL TONIGHT, AND I KNOW EXACTLY WHAT'S GOING TO HAPPEN. SHE'S GONNA LOCK THAT DOOR AND NOT LET ANYBODY IN THERE. SO, WHAT DO I DO? THE NEXT

THING, DO I GO TO THE NEWSPAPER AND SAY, LOOK THIS ELDERLY LADY LIVING IN HER POOP? I'M LIKE, I'M BESIDE MYSELF. I TRY TO KEEP MY HOUSE SPOTLESS AND I WILL HELP ANYBODY IN THIS NEIGHBORHOOD DO ANYTHING, BUT I JUST CAN'T LIVE LIKE THIS. I'M LIKE A KOOK IN MY OWN HOUSE. IT STINKS. I DIDN'T EVEN KNOW WHAT IT WAS. I KNEW SHE WAS A HEAVY SMOKER AND EVERYTHING LIKE THAT. BUT I NEVER KNEW THAT. SHE'S SCREAMING FOR HELP DOWN IN THE BASEMENT. SHE GAVE THE COPS A HARD TIME. THEY WERE ABOUT TO THROW UP AND THE MEDICS, BUT THAT'S OKAY. THAT'S OKAY BECAUSE THERE'S NOTHING WRONG WITH THE STRUCTURE. HOW ABOUT THE PLUMBING. THE TOILET IS SO FILTHY IN THE PICTURES YOU CAN SEE IT HASN'T BEEN FLUSHED IN MONTHS. SO, I GOTTA GET ROACHES AND RATS AND MICE THAT COST ME MONEY? I WORK TWO LITTLE JOBS TO TRY TO KEEP UP WITH MY INCOME AND I DON'T NEED TO BE PAYING FOR STUFF THAT I DON'T NEED. I GOT MOUSE BOXES LIKE THIS OUTSIDE OF MY HOUSE. HOW DO YOU THINK I FEEL? AND THE MOUSE POOP LOOKS BIGGER THAN THE MOUSE.

COMMISSIONER GOUGLER-FROM WHAT I UNDERSTAND THE HEALTH OFFICER WENT IN THERE. THAT'S ALL I KNOW WHAT HAPPENED AT THIS TIME. DOES ANYBODY ELSE KNOW ANYTHING?

COMMISSIONER FITZ-YEAH. I CAN COMMENT ON IT SINCE I HAPPEN TO LIVE ON THE SAME STREET. RITA, YOU DO KNOW THAT AS SOON AS THAT WAS BOUGHT TO MY ATTENTION, I DID EVERYTHING IN MY POWER TO CONTACT THE PROPER AUTHORITIES, PEOPLE AND SO ON TO TRY AND GET THIS RESOLVED. IS THAT CORRECT?

MS. VIDETTO -YOU DID BUT WHERE DID IT ... BUT APPARENTLY, WE DIDN'T EVEN GET TO THAT, TO THE PEAK YET.

COMMISSIONER FITZ-I UNDERSTAND, I FEEL FOR YOU. I UNDERSTAND IT. I SEE IT BUT WHAT I CAN TELL YOU IT'S A PROCESS TO TRY TO GET ALL THIS DONE. SHE STILL OWNS THAT RESIDENCE. AM I RIGHT MR. SOLICITOR?

MR. PIERCE, SOLICITOR-THAT IS CORRECT. THERE'S LIMITED THINGS THAT WE CAN DO. THE HEALTH OFFICER HAS BEEN CONTACTED. FOLKS IN THE COUNTY HAS BEEN CONTACTED.

MS. VIDETTO -I STARTED A CLAIM WITH COSA.

MR. PIERCE, SOLICITOR-I DON'T KNOW WHAT STANDING YOU WOULD HAVE TO DO THAT, ANYWAY THAT'S ALREADY BEEN DONE AND YOU'RE WAITING TO HEAR BACK FROM THEM. EITHER FORTUNATELY OR UNFORTUNATELY WITH YOUR SITUATION THIS PERSON HAS RIGHTS. FROM WHAT WE UNDERSTAND FROM THE MEDICAL PROVIDERS IS THAT SHE IS ABLE TO LIVE BY HERSELF, INDEPENDENTLY AND THAT'S HOW THEY ARE GOING TO RELEASE HER FROM THE HOSPITAL. THAT IS NOT MY ASSESSMENT. I DON'T KNOW ANYTHING ABOUT THAT. I'M JUST TELLING YOU WHAT WE'VE BEEN ABLE TO FIND IN INVESTIGATION. WE ARE TRYING TO GET HER HELP. HER SON HAS BEEN CONTACTED. THEY ARE WORKING ON GETTING DONE. FIVE WEEKS IS NOT GOING TO BE SUFFICENT. YOU'RE GOING TO HAVE TO GET SOMEBODY IN THERE TO DO IT. WE ARE GOING TO TRY AND STAY ON TOP OF THAT ISSUE. SO, I KNOW THAT'S WHAT THE SON, QUOTE, SAID BUT THAT'S NOT SUFFICENT TO GET THAT PROBLEM SQUARED AWAY. THEY ARE WORKING ON IT AND

AGAIN THIS CAME TO MY ATTENTION AT 4:00 TODAY, SO THAT'S THE BEST ANSWER THAT I CAN GIVE YOU AT THIS POINT...

MS. VIDETTO-I UNDERSTAND THAT AND I... BUT WHAT MY THING IS. LIKE I KNOW WHAT'S GOING TO HAPPEN.

MR. PIERCE, SOLICITOR-YOU MIGHT THINK YOU KNOW WHAT'S GOING TO HAPPEN WITH ALL DUE RESPECT...

MS. VIDETTO-BECAUSE I'VE BEEN DEALING WITH THIS FOR YEARS AND I DID'NT REALIZE HOW BAD IT HAD GOTTEN.

MR. PIERCE, SOLICITOR-AND NOW THE PROPER AUTHORITIES ARE GOING TO GO IN AND HOPEFULLY GET SOME RELIEF FOR THIS.

COMMISSIONER FITZ-UNFORTUNATELY I DON'T THINK ANYBODY KNEW HOW BAD THIS HOUSE WAS UNTIL THIS CAME TO LIGHT THIS WEEKEND. AM I CORRECT? AND THE OTHER UNFORTUNATE THING IS WE DON'T HAVE THE AUTHORITY JUST TO CHANGE HER LOCK AND SHUT HER OUT OF HER OWN DWELLING.

MS. VIDETTO -NO. BUT I'M NOT SAYING THAT. THE CASEWORKER SPOKE WITH ME AND THEY TOLD ME THAT THEY WAS TO STICKER THAT DOOR IN THERE UNTIL IT GOT CLEAN, THEY WOULD FIND PROPER HOUSING FOR HER UNTIL THAT HOUSE...

MR. PIERCE, SOLICITOR-RIGHT AND THAT'S WHAT THEY'RE WORKING ON RIGHT NOW. IT DOES'NT HAPPEN IN TEN MINUTES.

MS. VIDETTO -BUT HOW DO YOU GET THE HOUSE ...

MR. PIERCE, SOLICITOR-AGAIN, AS COMMISSIONER FITZ HAS INDICATED, IT'S A PROCESS. WE JUST CAN'T GO IN AND SAY, WE'RE DOING THIS. IT DOESN'T HAPPEN THAT WAY. YOU WOULD'NT LIKE IT IF IT WAS YOUR HOUSE. IF IT IS A RELATIVE OF YOURS. THERES ALWAYS TWO SIDE OF EVERY STORY. SO, WE HAVE TO RESPECT WHAT THEIR POSITION IS AS AN INDEPNDENT, PRIVATE PERSON. WE ARE TAKING STEPS NECESSARY TO DO AN INVESTIGATION. THE TOWNSHIP HAS DONE IT. THE POLICE DEPARTMENT, THE HEALTH DEPARTMENT AND COMMISSIONER FITZ HAS BEEN SPEARHEADING IT. AGAIN, THIS IS JUST COMING TO OUR ATTENTION AT 4:00 TODAY. IT'S NOT GOING TO HAPPEN AS QUICKLY AS YOU WANT. IT NEVER DOES. IT'S FRUSTRATING, I GET IT. BUT WE'RE TRYING TO OPERATE WITHIN THE LAW AND GET THE PROPER CHANNELS SQUARED AWAY. THAT'S ALL I CAN TELL YOU.

MS. VIDETTO -I UNDERSTAND WHAT YOU ARE SAYING... BUT I JUST... I'M GLAD THAT SOMEBODY, YOU KNOW I UNDERSTAND THAT EVERYBODY IS TRYING TO HELP. BUT THIS HAS BEEN GOING ON LIKE...

COMMISSIONER GOUGLER-BANGS THE GAVEL.

MS. VIDETTO -ALRIGHT. THANK YOU FOR YOUR HELP.

CAROL BADGETT-I WANTED TO KNOW, YOU KNOW, WE PAY OUR TAXES AND EVERYTHING AND I PAID MY TAXES BUT THE TAXES WENT UP FIVE HUNDRED DOLLARS MORE THAN THEY DID LAST YEAR. SO, MY THING TO YOU IS THAT I'M

A SENIOR CITIZEN. I AIN'T GOT NO CHILDREN THAT GO TO SCHOOL AND I WANTED TO KNOW IF THERE IS ANY WAY POSSIBLE THAT THE TAXES COULD BE, YOU KNOW, GRANDFATHERED IN SO THAT, I DON'T MIND PAYING THE TAXES BUT I DON'T WANT THEM TO KEEP ON GOING UP.

COMMISSIONER TALIAFERRO-CAN WE GET YOUR NAME PLEASE?

MS. BADGETT-CAROL BADGETT.

COMMISSIONER TALIAFERRO-ADDRESS?

- MS. WHITAKER, MANAGER-ARE YOU TALKING ABOUT YOUR TOWNSHIP TAXES?
- MS. BADGETT-NO, THE SCHOOL TAXES.

COMMISSIONER SMITH-THAT'S NOT US.

- MS. BADGETT-THE SCHOOL TAXES WENT UP FIVE HUNDRED DOLLARS.
- MR. PIERCE, SOLICITOR-WE DON'T HAVE CONTROL OVER THAT.

COMMISSIONER SMITH-YOU HAVE TO GO TO THE SCHOOL BOARD MEETING.

BARRY MERLINO, TAX COLLECTOR-CAN I ADDRESS THAT BOB?

MS. BADGETT-WHEN IS THE SCHOOL BOARD MEETING?

BARRY MERLINO, TAX COLLECTOR-IF I COULD ADDRESS THAT FOR A MOMENT. BIG PROBLEM THIS YEAR. THINGS DIDN'T START WITH THE SCHOOL. IT STARTED WITH THE TAXES IN GENERAL, COUNTY, TOWNSHIP AND SUCH BECAUSE OF THE REASSESSMENT. OKAY, THAT'S WHAT HAPPENED. SOME PEOPLE'S TAXES WENT UP AND YOUR PROBABLY ONE OF THEM AND AS MUCH AS YOU'RE GOING TO HATE HEARING THIS, SOME PEOPLE WENT DOWN. OKAY? THAT'S WHAT HAPPENED. OKAY? I HAVE A BEAUTIFUL THING IN THE OTHER ROOM. I GOT IN THE OTHER ROOM, I COULD BRING IT OUT AND GIVE IT TO YOU. IT'LL EXPLAIN IT A LOT BETTER THAN I COULD. BUT HERE'S WHAT I WOULD TELL OF ANYBODY WHOSE CALLED ME WITH THE SAME PROBLEM. WHEN THIS ALL-HAPPENED LETTERS WERE SENT OUT TO ALL THE RESIDENTS THAT THEY COULD COME IN AND TALK ABOUT AND CHALLENGE THE ASSESSMENT. I'M JUST SAYING THAT'S HOW THAT'S DONE. NOW, YOU CAN STILL DO THAT NOW. THE UNFORTUNATE THING I THINK IS GOING TO HAPPEN IS THAT YOU MIGHT HAVE TO PAY FOR THAT REASSESSMENT. IT'S NOT A GUARANTEE BUT IT'S ALWAYS SOMETHING. I HAVE THE FORM IN THE OTHER ROOM WITH THE ADDRESS OF THE CONTACT. BUT, LIKE I SAID, EVERYBODY SAYS THE SAME THING. NOW WHAT'S IMPORTANT TO ME IS TO MAKE SURE AS TAX COLLECTOR THAT YOU'RE GETTING WHAT YOU CAN ANYWAY. THE HOMESTEAD EXEMPTION. I GOTTA MAKE SURE YOU'RE GETTING THAT NOW. PEOPLE ARE ELIGIBLE FOR AND PROBABLY HAVEN'T GOTTEN FOR YEARS BUT THAT'S SOMETHING I COULD CHECK FOR YOU IF YOU CALL ME. ALSO, THERE'S A REBATE. IT'S A PA-1000, I'M NOT QUITE SURE THAT YOU CAN APPLY ON YOUR TAXES AT THE END OF THE YEAR. IT'S NOT A GREAT AMOUNT OF MONEY BUT IT'S SOMETHIBG. I TELL EVERYBODY THAT COMES IN THERE AND UH, IT'S REALLY GOING TO UPSET A LOT OF SCHOOL PEOPLE AND TOWNSHIP PEOPLE. EVERYBODY GOES IN THERE. YOU PAY FOR YOUR FOOD. YOU PAY FOR YOUR MEDICINE. YOU PAY TO KEEP YOU SAFE. THE LAST THING YOU PAY ARE YOUR TAXES. THAT'S EVERYBODY, BECAUSE THE TOWNSHIP, THE SCHOOL. TASK CLAIM WILL WORK WITH ANYBODY, WITH A PAYMENT PLAN. YOU COULD ALMOST NAME WHAT YOU CAN AFFORD. SO, IT'S SOMETHING THAT, YOU DON'T HAVE TO WORRY ABOUT GETTING KICKED OUT. IT DOES'NT SOLVE YOUR TAXES GOING UP BUT THERE'S SOME HELP OUT THERE. ALSO, LAST THING, I WOULD ASK YOU TO CALL YOUR STATE REPRESENTATIVE. TALK TO THEM ABOUT WHAT YOUR PROBLEMS ARE. THERE'S A THING GOING ON RIGHT NOW WITH THE LEGISLATURE IN THE STATE OF PENNSYLVANIA. I HATE TO EVEN MENTION HERE BUT I WILL THAT UH, SOMEONE'S TRYING TO GET SCHOOL TAXES IN THE STATE OF PENNSYLVANIA PAID BY THE STATE. THAT'S A TWO EDGE SWORD. OKAY? I'M NOT SURE HOW THAT'S GOING TO WORK, BUT STOP IN AND SEE ME.

MS. BAGGETT-OKAY. BUT MY THING IS IF THE SCHOOL TAXES AGAIN GOING TO GO UP ANOTHER FIVE-HUNDRED DOLLAR NEXT YEAR?

BARRY MERLINO-TAX COLLECTOR-I DOUBT IF THEY'LL EVER GO UP THAT MUCH AGAIN. THEY COULD GO UP. THEY COULD BUT THIS WAS AN EXTRAODINARY YEAR. IT HAPPENED BEFORE. MIKE HELP ME, ABOUT HOW LONG AGO DID WE HAVE THE REASSESSMENT.

MR. PIERCE, SOLICITOR-TWO THOUSAND.

BARRY MERLINO, TAX COLLECTOR-TWO THOUSAND IT HAPPENED. BUT IT HAPPENED TO YOUR TOWNSHIP TAX AS WELL. EVEN THOUGH IT WASN'T AS MUCH.

MS. BAGGETT-RIGHT. RIGHT. THAT'S WHAT I'M SAYING. I'M OKAY WITH IT GOING UP BUT NOT FIVE HUNDRED DOLLARS.

BARRY MERLINO, TAX COLLECTOR-I KNOW. IT'S A LOT. I CAN'T GIVE YOU ANY BETTER ANSWER THAN THAT BUT TRY TO GET THE ASSESSMENT CHANGED. YOU COULD DO THAT.

MS. BAGGETT-I WAS GOING TO GIVE YOU A CALL TOMORROW. IS THAT OKAY WITH YOU?

BARRY MERLINO, TAX COLLECTOR- NOT REALLY (LAUGHTER). THAT'S FINE.

BUT YOU'RE GOING TO HEAR FROM ME (LAUGHTER) THANK YOU.

COMMISSIONER GOUGLER-PUBLIC COMMENT IS CLOSED.

COMMISSIONER LACEY MOVED TO APPROVE THE MINUTES FOR SEPTEMBER 8, 2021, MEETING. IT WAS SECONDED BY COMMISSIONER GOUGLER.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? FOUR APPROVED. MOTION CARRIED. COPY ATTACHED.

COMMISSIONER LACEY MOVED TO APPROVE THE BILL LIST FOR AUGUST AND SEPTEMBER 2021. IT WAS SECONDED BY COMMISSIONER TALIAFERRO.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? FOUR APPROVED. MOTION CARRIED. COPY ATTACHED.

COMMISSIONER LACEY MOVED TO REMOVE DEBORAH DILUZZIO AS THE ZONING BOARD SECRETARY, EFFECTIVE IMMEDIATELY. IT WAS SECONDED BY COMMISSIONER FITZ,

MS. WHITAKER, MANAGER- SHE'S NOT ON THE BOARD. SHE WAS APPOINTED AS SECRETARY AND DIDN'T FOLLOW THROUGH WITH UM, THE APPOINTMENT. AND... TINA HAS REACHED OUT TO HER; MS. BEA HAS REACHED OUT TO HER. SHE IS AWARE AND SHE JUST HASN'T BEEN RESPONSIVE.

COMMISSIONER GOUGLER-OKAY. ALL THOSE IN FAVOR? MOTION PASSES. FOUR APPROVED. MOTION CARRIED.

COMMISSIONER LACEY MOVED TO APPOINT TINA SHUTTER, ZONING BOARD SECRETARY, EFFECTIVE IMMEDIATELY. IT WAS SECONDED BY COMMISSIONER GOUGLER.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? FOUR APPROVED. MOTION CARRIED.

COMMISSIONER LACEY-I'D LIKE TO CONSIDER A MOTION TO ADOPT THE ZERO WASTE CONVENTA RESOLUTION 2021.

COMMISSIONER SMITH-SECOND.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? ANY NEGATIVES? FIVE APPROVED. MOTION CARRIED.

COMMISSIONER LACEY-I'D LIKE TO CONSIDER A MOTION TO APPROVE THE STIPULATIONS BETWEEN DELCO TRUCK SALES IN THE TOWNSHIP OF DARBY FOR THE QUIET TITLE PORTION OF THE PAPER STREET KNOWN AS MORGAN TERRACE. IT WAS SECONDED BY COMMISSIONER FITZ.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? ANY NEGATIVES? MOTION CARRIES.

FOUR APPROVED. MOTION CARRIED.

COMMISSIONER LACEY-I'D LIKE TO CONSIDER A MOTION TO AUTHORIZE THE SOLICITOR TO PREPARE THE WAWA AGREEMENTS. IT WAS SECONDED BY COMMISSIONER SMITH.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? ANY NEGATIVES? MOTION CARRIES.

FIVE APPROVED. MOTION CARRIED.

COMMISSIONER FITZ-CONSIDER A MOTION TO APPOINT ANDREW CONNELLY, WARD III TO THE PARKS AND RESCRESTION BOARD, EFFECTIVE IMMEDIATELY. COMMISSIONER TALIAFERRO-SECOND.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? ANY NEGATIVES? FIVE APPROVED. MOTION CARRIED. COMMISSIONER FITZ-CONSIDER A RESOLUTION ELIMINATING POLICE OFFICERS' CONTRIBUTION TO THE POLICE PENSION PLANS FOR THE YEAR 2022.

COMMISSIONER SMITH-I SECOND.

MR. PIERCE, SOLICITOR-I THINK THE TOWNSHIP MANAGER MAY WANT TO GIVE A LITTLE BIT OF AN EXPLAINATION ABOUT THIS.

HOWEVER, WE DID GET THE MINI PROS FOR THE OPEN SPACE AND RECREATION PLAN. I HAVE A MEETING TOMORROW NIGHT WITH THE PLANNING COMMISSION TO REVIEW THE ACT 537 FOR DELCORA AND THE SANITARY/SEWER AMMENDMENT THAT HAS TO GO TO EDP. THAT'S FOR THE LONG-RANGE, LONG-TERM CONTROL PLANS. THERE ARE CERTAIN CRITERIA THAT HAVE TO BE FOLLOWED IN ORDER FOR DELCORA TO COMPLETE, UM TO DO THE TREATMENT IN THE MUNICIPALITY. COMMISSIONER SMITH-I CAN'T SEND YOU EMAILS BECAUSE WHEN I SEND YOU EMAILS, APPARENTLY, I ON'T KNOW IF I'M BEING BLOCKED OR NOT. BUT IT KEEPS KICKING BACK. I DID TELL THE TOWNSHIP MANAGER AND THE BOARD PRESIDENT THAT EVERYBODY GETS AN EMAIL EXCEPT FOR YOU AND IT COMES BACK...

MS. WHITAKER, MANAGER-SO REGARDING ARNOLD COVERT PARK, I CAN TELL YOU THAT I MET WITH JAMIE ANDERSON. WHOSE A COORDINATOR WITH STORMWATER EASTERN DELAWRARE COUNTY STORMWATER AUTHORITY THAT WE'RE MEMBER OF. AND BECAUSE OF THE MASTER PARK PLAN THAT'S GOING TO HAPPEN IN CONWAY PARK, WE MOVED THE PECO GREEN REGION GRANT THAT WE RECEIVED, AS WELL AS THE PENNSYLVANIA HORTICULTURAL GRANT THAT WE RECEIVED OVER TO ARNOLD COVERT PARK. WE'RE GOING TO WORK ON THE STREAM BANK AND ALSO PLANT SOME TREES THERE AND ALSO IN THE AREA CLOSER TO THE PLAYGROUND TO MAKE IMPROVEMENTS AND WE'LL ADD A NOTATION THAT IT NEEDS SOME LIGHTING OVER THERE. THE LIGHTING WON'T BE COVERED BY THE GRANT SO THAT'S SOMETHING THAT THE BOARD WILL HAVE TO LOOK AT DOWN THE ROAD. SO, WE ARE MAKING IMPROVEMENTS TO THAT AREA. AND TO FOLLOW UP ON THE STATEMENT YOU SAID THERE'S A TEN THOUSAND DOLLAR DONATION. WHERE IS THAT FROM AND WHAT IS THAT FOR?

COMMISSIONER SMITH-THAT'S FOR THE BASKETBALL COURT TO BE RESURFACED.

MS. WHITAKER, MANAGER-ARE THEY SENDING THAT TO THE TOWNSHIP?

COMMISSIONER SMITH-IN DUE TIME WHEN WE GET OTHER THINGS WE NEEDED. WE HAVE SOME INVESTORS WORKING IN THE COMMUNITY STATE QUARTERS. I'D LIKE TO DO SOME THINGS, UM, ALSO COMMISSIONER TALIAFERRO OR TOWNSHIP MANAGER THE YELLOW BENCH THAT WAS TAKEN OUT BECAUSE IT WAS BROKEN UP, DID YOU GET A CHANCE TO LOOK AT IT OR ORDER ANOTHER ONE YET?

MS. WHITAKER, MANAGER-WE HAVE NOT.

COMMISSIONER SMITH-AH, CAN YOU ORDER ANOTHER ONE? WE HAVE TO MOVE BUSINESS.

MS. WHITAKER, MANAGER-YOU CAN BRING IT UP.

COMMISSIONER SMITH-I MEAN YOU PUT IN. IT WAS BROKEN UP AND WE NEED IT REPLACED BECAUSE THE SENIORS WON'T BE ABLE TO SIT DOWN AND ENJOY THEMSELVES. WE HAVE SENIORS THAT GO DOWN THERE IN THE DAY TIME. THAT BENCH THAT HAD A BACK PIECE TO IT, THEY CAN'T SIT BACK BECAUSE THERE IS NOTHING THERE FOR THEM TO SIT ON.

MS. WHITAKER, MANAGER-OKAY.

COMMISSIONER SMITH-THANK YOU.

COMMISSIONER TALIAFERRO-SEND ALL THAT IN AN EMAIL AND I WILL MAKE SURE TONIGHT YOU HAVE MY CORRECT EMAIL...

COMMISSIONER SMITH-THE ONE I'M SENDING TO DARBY TOWNSHIP; IT KEEPS COMING BACK.

COMMISSIONER TALIAFERRO-IT REALLY SHOULD'NT BE GETTING KICKED BACK BECAUSE I GET EMAILS ALL THE TIME.

COMMISSIONER SMITH-THANK YOU.

COMMISSIONER GOUGLER-ALRIGHT. ANY NEWE BUSINESS?

MS. WHITAKER, MANAGER-COMMISSIONER SMITH DIDN'T GO YET.

COMMISSIONER SMITH-ITEM A WAS TAKEN CARE OF. I WANT TO THANK THE HIGHWAY DEPARTMENT FOR TAKING CARE OF THAT. BUT YOU KNOW THE CLEANING AND GETTING THE TRASH UP IN THE REAR OF THE 1400 BLOCK OF (INAUDIBLE). HOOK ROAD CLEAN UP. THE TRASH AND DEBRIS FROM CLIFTON AVENUE TO BURTON AVENUE NEEDS TO BE ADDRESSED. WE KEEP TALKING ABOUT THIS SAME MATTER. FROM MY UNDERSTANDING, I WAS TOLD THAT IT WAS THE CHURCH'S OROPERTY. THAT SIDEWALK ON CLIFTON AVENUE GOING BACKWARDS BURTON AVENUE TO NOBLET STREET. SO, IF WE COULD SEND A LETTER TO THE CHURCH AND HAVE THEM CLEAN THAT AREA. FIRST AME CHURCH AND THEN THE PORTION OF THE CHURCH THAT BELONGS TO THE TOWNSHIP OF DARBY, IF WE CAN LOOK AT THE BRIDGES. PART OF THE BRIDGE IS MISSING. I DON'T WANT A CHILD TO FALL THROUGH THAT BRIDGE AREA AND WE NEED TO MAKE SURE THAT HOOK ROAD IS CLEANED UP. I DID TALK TO PENNDOT, AND PENNDOT STATED THAT IT IS THE RESPONSIBILITY OF THE TOWNSHIP OF DARBY. JUST AS YOU PAINTED HOOK ROAD, HALF OF HOOK ROAD, IT NEEDS TO BE COMPLETELY PAINED WITH THE YELLOW PAINT. SO, THAT'S ALL I HAVE FOR NEW BUSINESS.

COMMISSIONER GOUGLER-DOES ANYBODY ELSE HAVE ANY NEW BUSINESS?

MS. WHITAKER, MANAGER-I HAVE AN ITEM UNDER NEW BUSINESS. ASKING FOR THE BOARD'S APPROVAL TO HAVE KEYSTONE FIRE PROTECTION COMPANY INSPECT AND MAKE NECESSARY REPAIRS TO THE POLICE ADMINISTRATION BUILDING. THE SPRINKLER SYSTEM. WE STARTED THIS PROJECT PRIOR TO COVID. THEY APPARENTLY WAS SHUT DOWN. THEY SENT A NEW PROPOSAL TO OUR HIGHWAY SUPERVISOR. I WAS GIVEN THIS TODAY AND THIS IS A PRIORITY. WE ALSO HAD THE ADJUSTER GO DOWN TODAY AND LOOK AT THE ROOF AGAIN AND NOTICED THAT

WHAT APPEARED TO BE SOME FIRE DAMAGE, SOME SCORCHING, I SHOULD SAY BECAUSE WE KNOW THERE WASN'T A FIRE THERE, BUT SOME SCORCHING. SO, THEY ARE GOING TO FOLLOW UP AND SEND ME A REPORT REGARDING THE ROOF. THAT WHOLE SIDE OF THE ROOF THAT NEEDS TO BE DONE AND SO, I'LL LET THE BOARD KNOW ABOUT THAT. BUT IN THE MEANTIME, THE SPRINKLER SYSTEM NEEDS TO BE FIXED AS WELL. THE COST IS \$4,002.00.

COMMISSIONER LACEY-DO WE NEED A MOTION?

MR. PIERCE- WE DO NEED A MOTION FOR THAT YEAH, BECAUSE IT'S AN EMERGENCY BASIS (INAUDIBLE).

COMMISSIONER SMITH-I HAVE A QUESTION BEFORE WE MAKE THE MOTION, UM, IS THERE (INAUDIBLE) BECAUSE THE LAST PERSON THAT CAME OUT TO GET THE BID FOR THAT ROOF REPLACEMENT, THE ROOF WASN'T REPLACED YET.

MS. WHITAKER, MANAGER- NO. NO WORK HAS BEEN DONE TO THIS AREA.

COMMISSIONER SMITH-IT'S BEEN OVER SIX, SEVEN MONTHS SO I KNOW THE CONTRACTOR HAS BEEN WAITING PATIENTLY. I DON'T KNOW WHAT HAPPENED. WE HAD AN ADJUSTER COME DOWN ADJUSTING AGAIN TODAY...

MS. WHITAKER, MANAGER-WE HAD AN ADJUSTER COME DOWN AND THEN WE HAD A STRUCTUAL ENGINEER COME DOWN. I HAVE REACHED OUT TO THEM. THE LAST COMMUNICATION I RECEIVED FROM THEM WAS ON SEPTEMBER 6TH. I CONTACTED THEM TWO ADDITIONAL TIMES. YESTERDAY EVENING I CONTACTED OUR INSURANCE AGENT TO LET THEM KNOW THEY WERE NON-RESPONSIVE. SO, OUR INSURANCE AGENT ACTUALLY CAME DOWN HIMSELF TO LOOK AT IT, CLIMBED UP, TOOK PICTURES AND THEY ARE GOING TO EXPEDITE THIS PROCESS.

COMMISSIONER SMITH-IS THIS SOMETHING WE CAN DO ALL TOGETHER AT ONE TIME, REPLACING THE ROOF, FIXING THE ROOF AND THE SPRINKLER SYSTEM?

MS. WHITAKER, MANAGER-THEY ARE TWO DIFFERENT COMPANIES. THIS DOESN'T HAVE ANYTHING TO DO WITH THE ROOF.

COMMISSIONER SMITH-OKAY.

COMMISSIONER LACEY-I MAKE A MOTION TO APPROVE THE SPRINKLER SYSTEM.

COMMISSIONER SMITH-SECOND.

COMMISSIONER GOUGLER-ALL THOSE IN FAVOR? ANY NEGATIVES? MOTION CARRIES. FIVE APPROVED. MOTION CARRIED.

COMMISSIONER SMITH-MR. PRESIDENT, I'M SORRY. JUST ONE LAST ITEM. AT THE 2 STUDEVAN PLAZA AREA, THE LIGHTS HAVE BEEN OUT FOR OVER TWO, THREE MONTHS NOW. CAN WE FIND SOMEONE TO GET DOWN THERE AND MAKE SURE THE TIMER IS CORRECT? WE HAVE CHILDREN PLAYING FOOTBALL AND THE GIRLS ARE CHEERING IN THE DARK. IT WAS DARK AT THE LAST COMMISSIONERS MEETING DOWN THERE AND IT STILL HASN'T BEEN RESOLVED. IF WE CAN'T DO IT CAN LENNI COME OUT AND SEE WHAT THE PROBLEM IS IMMEDIATELY? THAT'S A SAFETY ISSUE. I TALKED TO THE CHIEF; HE COULDN'T FIND THE SWITCH

BACK THERE. THE HIGHWAY DEPARTMENT COULD'NT FIND IT. SO, MAYBE WE COULD BRING AN ELECTRITION IN TO FIND OUT WHY THOSE LIGHTS ARE OUT.

CHIEF SOUSA-WE ONLY HAVE THE ABILITY TO TURN THE REAR ON AND TO SET THE TIMER FOR THE LIGHTS OUT FRONT.

MS. WHITAKER, MANAGER-RIGHT. THAT'S WHAT I WAS ADVISED BY THE HIGHWAY SIUPERVISOR.

CHIEF SOUSA-SO LIKE I SAID, I DON'T KNOW, IF WE COULD HAVE THE GUYS DOWN THERE WHEN THE LIGHTS ARE OUT. WE DON'T HAVE ANYTHING SPECIFIC TO A TIME. WE DEFINITELY NEED TO GET IT LOOKED AT. THE BACK PART OF THE POLICE DEPARTMENT USE TO BE ON A TIMER AND THAT'S NOT WORKING EITHER, SO...

MS. WHITAKER, MANAGER-OKAY.

COMMISSIONER SMITH-THANK YOU. I'D LIKE TO MAKE A MOTION TO ADJOURN.

COMMISSIONER GOUGLER-SECOND. ALL THOSE IN FAVOR? FIVE APPROVED. MOTION CARRIED.
